PRESIDENT'S NOTEBOOK

Delaware will hold its Primary Election on September 14. There are only a few races of interest to the DSSA. At the top of the ticket is the Republican primary for U.S. Senate between Michael Castle and Christine O'Donnell. The winner will face Christopher Coons in November. As governor and representative Mr Castle has been consistently and aggressively anti-gun. He has sponsored and voted for a host of anti-gun legislation and has never failed to oppose pro-gun bills. In sharp contrast Ms. O'Donnell in 2008 and now has been consistently pro-gun. I do not doubt that if elected she would be a strong advocate for the right to keep and bear arms in the U.S. Senate. As surely as Mike Castle has earned his "F"; **Cristine O'Donnell has earned your support.**

The race for the U.S. House of Representatives features Michelle Rollins versus Glen Urquhart. Both candidates have submitted strong pro-gun questionnaires to the NRA and both have expressed strong pro-gun beliefs during the campaign. It is my opinion that either would be much better for law abiding gun owners than the Democrat. Since I do not have a crystal ball or access to the latest polls I do not know which has the better chance on November 2 you will need to decide for yourself. Rose Isso is also in the race and has expressed strong pro-gun views however her candidacy appears marginal.

In the Delaware Senate there are two very important races. In Senate District 9 the incumbent **Joseph Booth** is being challenged by Eric Bodenweiser. Senator Booth during his previous service in the House and while in the Senate has a proven track record as a strong advocate of the right to keep and bear arms. Since no Democrat has filed for this seat the primary is the election. I urge all registered Republicans in the 19th Senatorial District to **vote for Senator Joseph Booth** on September 14. In the neighboring 20th Senatorial District there is a primary on the Democratic side between incumbant **George Bunting** and Mitchell Perry. Senator Bunting has been a reliable friend of gun owners in the Senate and most notably with tact and diplomacy he rendered ineffective the appearance James Brady of Handgun Control Inc. on the Senate floor. Since there are no candidates from any other parties in this district the primary is the election and I urge all registered

Democrats to **vote for Senator George Bunting** on September 14.

There are several primaries for the Delaware House of Representatives and at this time we do not enough reliable information to make meaningful recommendations. However, please be assured that once all the questionnaires have been received and fully reviewed the DSSA will issue complete candidate grades prior to November 2. In the meantime please press any candidate who shows up at your door or elsewhere for his or her views on the right to bear arms, concealed carry etc. I would request that you share their responses with us by sending an e-mail to delsports.net or calling 302-764-6899. It would be very helpful for us to know whether the answers given to potential voters match the responses found in the questionnaires.

Alert: Check Your Wallet

Two weeks ago I had occasion to speak to an investigator from the Office of the Attorney General who had contacted me regarding some concealed carry training I had performed. After clearing up his concerns he informed me that my concealed carry license had expired in 2008. I went scrambling for my wallet to confirm that he was incorrect and found my permit issued in 2008 which does not expire until May 31, 2011. It appears that he checked the DELGIS computer system and it does not show my renewal in 2008. In 2009 concealed carry license information was added to the DELGIS system so as to allow police officers to confirm permits tendered to them by licensees in the same way an officer can confirm the validity of a drivers license.

With DELGIS having incorrect data I could end up under arrest because a police officer would get the wrong information when checking the validity of my license. The officer in that situation would have to decide whether to take me into custody or release me pending further investigation. I hope that will not happen because I have sent the investigator a copy of my current license and he has advised that he has corrected the records.

Unfortunately mine is not an isolated incident. Last spring a state senator told me that the Prothonotary's Office would not act on his renewal application because his permit had expired in 2007. Like me he found his permit issued in 2007 in his wallet and provided the Prothonotary with a copy. Thereafter the office processed and issued his renewal permit.

The DSSA is in the process of working with the Superior Court and the DELGIS staff to correct and complete the records so that some law abiding permit holder does not have to rely on the discretion of police officer to avoid cuffs and a ride to lockup pending a check of the records.

He graduated from Laurel High School in 1939, and after graduation, he worked for the DuPont Company as an electrician until his retirement in 1983. He enlisted in the Army Air Corp in 1941 until 1945, serving overseas in Europe as a crew chief in the 357th Fighting squadron on the P-51 Mustang Fighter Plane. He was very proud of the fact that Chuck Yeager, the man famous for breaking the first in flight sound barrier, also belonged to the 357th Fighting squadron. Joe had many enjoyments in life, and loved to lend a helping hand in the community. He enjoyed flying his own plane for a short time after returning home from the Air Corp, fishing, making his own lead cast lures and hand painting them. Among many other accomplishments, he spent a lot of time promoting the shooting sport by creating the Laurel Rifle Club, and enjoyed reloading his own ammo with a big effort toward achieving the best accuracy. He was an NRA Certified Safety instructor and taught Delaware Hunters Education classes for many years, as well as women personal protection classes. He was the past director of the Sportsman Association, past member of the Bridgeville Rifle & Pistol Club, a member of the Nanticoke Sportsman club, a charter member of Odd Fellows Charity Lodge #27, Rebekahs, Charter member of the American Legion Post #19, VFW Post 8276 in Delmar, Md., Laurel Alumni Association, AARP Seaford Chapter #1084, and a member of Centenary United Methodist Church. He was also well known for starting dinners at the VFW to raise money for the Laurel Library building fund. Mr. Stoakley is survived by his loving and devoted wife of 53 years, Mary Short Stoakley; his sons, Dean J. Stoakley of Delmar, Darryl Stoakley of Laurel and Douglas Stoakley of Millsboro; a daughter, Diane Urban and husband Joe W. Urban I of Newark; and grandchildren, Blair Stoakley, Ryann Urban, Joshua Urban and Joseph Urban II. His pet cat, Knight and several nieces and nephews also survive him. In addition to his parents, he was preceded in death by a sister, Louise C. Phillips, in 2002. Mark Your Calendar

Beginning April 29 through May 1, 2011 the NRA will host its Annual Meeting in Pittsburgh Pennsylvania. Please make your plans to attend. You will not regret it. Do not put it off hoping that maybe it will be closer in the future. Given the political climates in Philadelphia and Baltimore it is very unlikely.

When selecting a meeting site the NRA looks first at whether a potential host city has the facilities the handle large crowds of friendly and peaceable attendees. Last May 72,000 showed up in Charlotte, North Carolina. To make it work the NRA needs meetings rooms to hold up to 10,000 plus an exhibit hall to display acres and acres of guns and accessories. With the exception of the SHOT Show, which is restricted to firearms dealers and their employees, you will never see a gun show that will come even close to what you will see in Pittsburgh next spring.

Every major gun manufacturer and importer will have a display or booth. Same goes for those that provide reloading equipment, targets, ammunition, components, knives, boots, clothing, safety equipment, optics and anything else that is shooting or hunting related. The displays are staffed with well trained and knowledgeable persons who will be happy to answer your questions from the general to the specific. For those that like to shop there will be plenty of clothing, knives, videos, magazines(both kinds) and accessories to examine and buy. There will be thousands of guns to shoulder and otherwise check out. While guns cannot be purchased some attendees have been known to negotiate some pretty good deals to be completed through an FFL holder later. In addition to the meeting and exhibit hall the NRA will present seminars throughout the weekend on everything from methods and equipment of concealed carry to gun club management. There will also be many collector displays showing excellent examples of the beauty and practicality of firearms design.

Since 1998 I have attended all but four Annual Meetings and I look forward to being in Pittsburgh next year. Each time has been a unique and rewarding experience. From my perspective the only thing wrong is that the event is too short. I always wish I had more time to attend this or that seminar. Why does the exhibit hall have to close a 6:00 pm when there is so much more I want to see?

Even if you cannot stay the whole three days it is still worth the visit. Friday is the least crowded day in the exhibit hall and is in itself worth the trip. For a gun owner and supporter of the right to keep and bear arms there no better place to than to be surrounded by thousands of guns, an endless supply of ammunition and supplies with the company of thousands of like minded persons who cherish their firearms and ther freedoms.
