The quotation which serves as the title for this piece has been attributed to many, including Thomas Jefferson, but in this case the quotation comes from a speech given by the abolitionist Wendell Phillips before the Massachusetts Anti-Slavery Society in 1852. More fitting for our purposes, perhaps, is a similar quotation taken from Andrew Jackson's Farewell Address, March 4, 1837, which reads as follows:

*"But you must remember, my fellow-citizens, that eternal vigilance by the people is the price of liberty, and that you must pay the price if you wish to secure the blessing. It behooves you, therefore, to be watchful in your States as well as in the Federal Government."*

Those prophetic words spoken so long ago by Andrew Jackson serve as the watchwords and operating principles of the Delaware State Sportsmen's Association as we work to safeguard the most basic right of all, the Right to Keep and Bear Arms for law-abiding citizens engaged in lawful pursuits here in the First State.

Election Day 2016 will soon be upon us. As President Obama so succinctly pointed out in multiple interviews and statements, "elections have consequences". The elections to be held just a few days from now on November 8<sup>th</sup> will be the most important and most consequential of our lifetime.

### **Three Very Special Candidates – Three Very Special Leaders**

Every year we ask our members to step forward and run for office. Every year we seek candidates to take on the responsibility of fighting for our rights and to represent our interests in government. And every year we look for people who have the drive and desire to be our leaders and to show us the way toward an honest and representative government. This year we have three very special candidates who have accepted the challenge and who have committed themselves to being the leaders we so desperately need – three very special candidates, indeed. "Why are these three candidates so special", you ask?

Because all three are members of your DSSA Board of Directors. One is running for the Delaware State Senate; one is running for the Delaware State House of Representatives and one is running for a seat on the Kent County Levy Court.

### **Delaware State Senate – Senate District #7**

Anthony Delcollo, Esq. is a member of the DSSA Board of Directors and one of the founders of the Delaware Association of Second Amendment Lawyers. Mr. Delcollo is a Republican running against long-time incumbent Democrat Senator Patricia M. Blevins, the President Pro Tempore of the Senate.

When we asked Anthony why he chose to challenge the most powerful member of the Senate he said: "It's a matter of principle. Not only is my opponent the "proud owner" of a very bad voting record when it comes to Second Amendment issues, she also owns a very poor record on a host of other issues that are important to the people of the 7th Senatorial District. Yes, Senator Blevins is a powerful member of her caucus and a powerful member of the Senate, but she has lost touch with the people of our district and has spent far too much time representing other interests and pushing a nationally-inspire agenda when she should have been representing the interests and desires of the people of her district. It's time for a change and if this is to be a "change election" then that change needs to begin at the top."

## Delaware House of Representatives District #17

James R. Startzman, is a member of the DSSA Board of Directors and an avid advocate for the constitutional rights of all law-abiding citizens to keep and bear arms for lawful purposes. Mr. Startzman is a Republican challenger running against NRA F-rated Democrat incumbent Kimberly Williams. This is Jim's second run for the Delaware House of Representatives. When we asked Jim why he is running again this is what he said:

"The people of the 17th Representative District deserve better than we have gotten from our current Representative. I believe that when you are elected to the House of Representatives you are duty-bound to represent the people of your district and not simply toe the party line as my opponent has done. Very few, if any, of her party-line votes actually represent the interests, desires or expectations of her constituents. The people of the 17th Representative District expect more and deserve more – I intend to give them more."

## Kent County Levy Court – District #5

John C. Sigler, Esq. is a member of the DSSA Board, the current DSSA President, a founding member of the Delaware Association of Second Amendment Lawyers, a current NRA Director and a Past President of the NRA. Mr. Sigler is a Republican challenger running against a two-term Democrat incumbent by the name of George Sweeney.

Given John's solid Second Amendment credentials and the fact that Delaware's Firearms Preemption Laws prevent the county government from passing any sort of gun laws, whatsoever, we were interested in hearing his reasons for running for this position. This is what he said:

"I have always been a staunch advocate for responsible and responsive government that is accountable to the people at all times and at all levels. I believe that government should work for all of the people all of the time, not just some of the people some of the time.

It's all about philosophy and a belief in, and a love for, our great nation, our state and Kent County. This is my home. County government is as close to the people as any governmental body can get. Although Levy Court commissioners are elected on a partisan basis, the Levy Court has a history of collegiality and of working on an almost non-partisan basis. Kent County Levy Court is in desperate need of true leadership. Being one of only seven commissioners I might actually be able to accomplish something of value for the people of Kent County."

These are three very special candidates and three very special leaders. Now it's your turn.... Now it's up to the voters.

## Metallic Silhouette Competition

Delaware Rifle and Pistol has a metallic silhouettes league every Monday evening from 7PM to 9PM. This event is open to the public and cost \$2.00 for the evening.

Metallic Silhouettes consist of 5 rams, 5 turkeys, 5 hogs and 5 chickens of descending size which are shot with any 22 cal rim fire pistol or rifle at a distance of 50'. You have 30 seconds to prepare and 2 minutes to shoot each 5 shot segment, rotating through the four types of silhouettes. We run 2 segments for a total of 40 shots.

Scoring is easy, one shot, one hit. Perfect score is 40.

The event is open to any age shooting pistol or rifle with open sights or optics. Many members bring their children, grand children and others normally shooting bench rest rifle.

Shooting steel silhouettes is fun and challenging.

## DELAWARE LAW ENFORCEMENT MARKSMANSHIP ASSOCIATION

The Delaware Law Enforcement Marksmanship Association (known as DLEMA) was established in the mid 1970's for the purpose of offering competitions for Law Enforcement officers. Dover PD and the Delaware State Police were the first to dedicate teams for these competitions. The National Rifle Association was instrumental in opening the competitions to a wide variety of handgun courses of fire and handguns were designated, stock and open class, and both semi autos and revolvers. This course of fire is designed specifically for the purpose of encouraging law enforcement officers to participate in competitive shooting using standard issue police duty firearms and so competitors do not incur the additional cost for specialized firearms or equipment. This match is an aggregate of the following stages.

Stage 1: 3 yards, double action - 6 shots one hand standing without support, 8 seconds.

Stage 2: 7 yards, double action - 12 shots, one or two hands standing without support position. Twenty seconds, includes reloading for second 6 shot string.

Stage 3: 15 yards, double action - 12 shots, one or two hands standing without support. Twenty seconds, includes reloading for second 6 shot string.

Stage 4: 25 yards, double action - 18 shots, one or two hands; 6 shots kneeling, from behind the barricade for cover and support; 6 shots standing left hand from behind the barricade; and 6 shots standing right hand from behind the barricade. Ninety seconds, includes reloading for subsequent 6 shot string.

The range used is the Nanticoke Sportsman Association in Seaford, DE. The completion has now ended, however a Winter league will begin in November, with the dates indicated below. Although the course of fire is Law Enforcement under NRA rules, DLEMA is open to the civilian shooters. All shoots began at 0900 hrs and weather dictates indoor or outdoor.
