DSSA CASE TAKES THE NATIONAL SPOTLIGHT

The nation is watching. Attorneys General from at least 39 other states are watching. Both pro-gun and anti-gun advocates are watching. Delaware and DSSA are at center stage. The stakes are high, emotions are high, everyone is watching, and Freedom is on the line.

On June 23, 2022, the United States Supreme Court handed down its landmark decision in New York State Rifle & Pistol Association v. Bruen, now well known simply as "Bruen". The Bruen decision was the culmination of a long and arduous fight by our sister organization, New York's NRA State Association, to vindicate the right to keep and bear arms and to knock down a blatantly unconstitutional law passed by the New York legislature in defiance of the Supreme Court's prior decisions in Heller and McDonald. DSSA helped in that fight as a "friend of the court" in what is known as an amicus brief – more than one, actually.

Now it's our turn. The spotlight has shifted from New York's NRA State Association to Delaware's NRA State Association, your DSSA.

On June 30, 2022, just 7 days after the Bruen decision, Delaware's Governor John Carney signed two bills into law in open defiance of the Supreme Court's teachings in Bruen, Heller and McDonald, knowing full well that both laws were patently unconstitutional. One of those laws placed a ban on commonly owned rifles, pistols and shotguns which our General Assembly intentionally mislabeled as "assault weapons". The other law banned most standard capacity rifle and pistol magazines, again intentionally mislabeling these commonly owned items as "high capacity magazines". In both cases, the General Assembly intentionally used those pejorative terms - "assault" and "high capacity" - to poison the debate and convince themselves and the unwitting general public of the righteousness of their cause – the gun-ban cause.

Governor Carney and the rabidly anti-gun majority party of the Delaware General Assembly were warned that if either

of those bills became law, the Delaware State Sportsmen's Association would do its duty as NRA's State Association in Delaware, and file suit challenging those laws on constitutional grounds. That warning was obviously ignored.

They actually told NRA and DSSA "sue us, we don't care. Let the courts figure it out."

True to its word, DSSA filed suit in the United States District Court for the District of Delaware challenging both laws. Joining the Delaware State Sportsmen's Association in its challenge to these laws as named plaintiffs in this important federal civil rights action were the Bridgeville Rifle and Pistol Club, the Delaware Rifle and Pistol Club, the Delaware Association of Firearms Licensees, plus individual plaintiffs, Madonna Nedza, Curtis Clements, James Hosfelt, Jr., Bruce Smith, Vickie Lynn Prickett and Frank Nedza.

The suit is captioned as Delaware State Sportsmen's Association, Inc., et al v. Delaware Department of Safety and Homeland Security, et al. We will call it simply "DSSA v. Delaware".

Following DSSA's lead, two other suits were also filed for the same purposes, Gray v. Attorney General and Graham v. Attorney General in which the Second Amendment Foundation and the Firearms Policy Coalition were additional named parties. Those actions have been consolidated with DSSA's cause of action. The goals are the same.

In an effort to further protect the citizens of the State of Delaware from the adverse effects of these blatantly unconstitutional and intentionally draconian measures, the Plaintiffs petitioned the Court for a Preliminary Injunction, asking the Court to bar Delaware's Department of Safety and Homeland Security and the Delaware State Police from enforcing these two bills. The U.S. District Court denied the Plaintiffs' motion. DSSA and the other plaintiffs in this case appealed the judge's ruling to the United States Third Circuit Court of Appeals. That appeal is currently pending.

To most Delawareans, DSSA's fight to have these two laws stricken from the books and the rights of Delaware gun owners protected seems like a local fight, and in many ways it is - just as the New York State Association's fight in Bruen seemed to be both personal and local to the members of the New York State Rifle and Pistol Association before the Supreme Court spoke.

Just as NYSRPA v. Bruen eventually took on greater and greater national importance, so too is DSSA v. Delaware becoming recognized for its potential national importance.

The issues in DSSA v. Delaware are both numerous and complex. Adding to the complexity of these numerous issues is the fact that many, if not most, of those issues will be issues of first impression before the court, and other courts will be looking to the Third Circuit to see how that court resolves those issues. The potential for DSSA v. Delaware to become another Bruen or Heller or McDonald is very real indeed.

As one might expect in a case of this importance, powerful forces have taken an interest and are attempting to assist – on both sides. In addition to the briefs (written arguments) filed by the parties in support of their respective positions on appeal, "friends of the court", known as "amici", have filed a number of briefs, known as "amicus briefs".

Briefs supporting DSSA's position that the District Court was wrong in denying the Motion for a Preliminary Injunction have been filed by the following organizations:

- 1. A brief by the National Shooting Sports Foundation
- A brief by 20 Attorneys General representing the states of Montana, Alabama, Georgia, Idaho, Indiana, Iowa, Kentucky, Louisiana, Mississippi, Nebraska, New Hampshire, North Dakota, South Carolina, South Dakota, Utah, Virginia, West Virginia and Wyoming.
- 3. A brief by Gun Owners of America
- 4. A brief by the Delaware Association of Second Amendment Lawyers
- 5. A brief by the International Law Enforcement Educators and Trainers Association, the Law Enforcement Legal Defense Fund, the National Association of Chiefs of Police

Additionally, our co-appellants have also filed a brief supporting and asserting their own arguments as to why these two draconian laws are unconstitutional and why the District Court's adverse decision must be reversed. This helps DSSA.

The other side also has its outside supporters. Chief among those adverse supporters is an amicus brief filed by the Attorney General of Massachusetts and the Attorneys General from New Jersey, California, Colorado, Connecticut, Washington D.C., Hawaii, Illinois, Maine, Maryland, Minnesota, New York (of course), Oregon, Pennsylvania, Rhode Island, Vermont and Washington – all deep "blue" states with long anti-gun and anti-freedom histories.

As one might expect, Michael Bloomberg's Everytown for Gun Safety, and the Giffords Law Center have also filed amicus briefs in opposition to DSSA and in support of our anti-gun Attorney General and Governor and supporting the blatant gun-grab attempt by the far-left Majority of the Delaware General Assembly. Many of us remember the rallies at Legislative Hall, the times when freedom-loving Delawareans packed the halls and balconies at Legislative Hall, and all of the things each of us have said and done to convince our elected officials to obey the constitution and abide by their oaths of office. And of course, we all remember the feeling of betrayal when those two measures passed in both Houses and Governor Carney ultimately ignored the Supreme Court's guidance in Bruen and the words of our own Delaware Constitution by signing those bills into law.

Many felt that this was simply a Delaware issue. But it is not.

A total of forty (40) state Attorneys General have "skin in the game." Every major pro-gun and anti-gun national organization has skin in the game. Top name lawyers from across the country have written briefs on both sides of the issue – names like David Kopel, Steve Halbrook, Dan Petersen, David Thompson and our own Francis Pileggi, just to name a few on our side.

No, this is no longer just a local issue of importance just here in tiny Delaware. This is now a national issue with your DSSA leading the way.

Yes! This is our fight – it's your fight. It is an important fight, maybe even as important as the fight so recently won by our sister organization in New York that we now know as "The Bruen Decision."

But that is not all – not by a long shot.

This is a fight being fought on two fronts simultaneously. The appeal currently pending in the Third Circuit Court of Appeals, described above, is just one front in this two-front war.

The appeal in the Third Circuit Court of Appeals just pertains to the federal constitutional issues in this case – primarily the Second Amendment. But there is much more to this case.

In addition to the federal constitutional issues, there are also state constitutional issues. Those issues have been removed to state court and are currently pending in the Superior Court in Kent County. Of primary concern is whether those two laws – the ban on rifles, pistols and shotguns termed "assault weapons", and the ban on standard capacity magazines termed "high capacity" – violate our own Constitution's Article I Section 20 which says that "A person has the right to keep and bear arms for defense of self, family, home and State, and for hunting and recreation."

This is a two-front fight, and both fronts are important. We must win them both. DSSA promised to fight this "war" and it is keeping that promise.

This fight is far from over. This is your fight – and you need to help.

The ammunition in this "war" is money. Lawyers are expensive, even when they are on our side – even when they believe as we do.

Do your part – go to DSSA.us and donate to the fight. Every dollar counts and every dollar will be needed in the very near future.

And, do not forget – we still have another suit pending called Birney, et al v. Delaware Department of Safety and Homeland Security. In the Birney case, DSSA is fighting for the rights of 18-21 year old adult citizens to enjoy the same rights as the rest of us. Old enough to vote, old enough to go to war, old enough to sign contracts and get married – old enough to enjoy the right to keep and bear arms for defense of self, home and family.

The far-left anti-gun crowd has declared war on Delaware's law-abiding gun owners and there are many more battles ahead. Your DSSA has sworn to defend your rights – this is your fight. Do your part. Freedom is not free.

NEW MEXICO - IT COULD HAPPEN HERE

Don't be fooled, it could happen here!

On Thursday, September 7, 2023, New Mexico's Democrat Governor Michelle Lujan Grisham issued an executive order that shocked the world when she declared "gun violence" to be a public health state of emergency for the City of Albuquerque and Bernalillo County, banning both concealed carry and open carry of firearms in that city and county. In her statement to the press, she openly admitted that her actions were unconstitutional but justified her actions by stating that neither the constitution nor her oath of office as governor were "absolute" – amazing!

When confronted by the Sheriff of Bernalillio County who announced that he and his officers viewed the governor's actions as blatantly unconstitutional she chided the sheriff by stating that she did not need lectures on the constitution from the sheriff. The Chief of Police for Albuquerque has also stated that the city's police force would not enforce the governor's unconstitutional declaration leaving only the New Mexico State Police to enforce the governor's political will.

On Sunday, September 10th, over 100 people peacefully rallied in historic Old Town Albuquerque to protest the governor's actions. Many, if not all, were openly armed and defiant, chanting "We will not comply!" There were no arrests.

OK, so that was New Mexico, so what does that have to do with Delaware, you ask? Good question.

Just a few short weeks ago, on March 14, 2023, Senate Concurrent Resolution 12 was introduced in the Delaware Senate and passed the same day by the Senate Democrats on a strict party line vote. That same day, March 14, 2023, SCR 12 passed the Democrat-controlled Delaware House of Representatives on a voice vote. Apparently even the House Democrats did not want their names on the record supporting the radical Senate Democrats on this measure.

So, what was Senate Concurrent Resolution 12 and what did it do, you ask? Another good question.

Delaware Senate Concurrent Resolution 12 declared socalled "gun violence" to be a "public health emergency" and by doing so set the stage for "gun violence" to fall under Sub-Chapter V of Chapter 31 of Title 20 – you guessed it -Delaware's Public Health Emergency Statute. And it was Attorney General Jennings who put out a press release at the conclusion of the last session of the General Assembly promising that Senate Substitute 1 for Senate Bill 2, the clearly unconstitutional "Permit-to-Purchase Bill", would pass and be signed by Governor Carney in January.

Neither Attorney General Jennings nor Governor Carney care about your God-given right to keep and bear arms for lawful purposes, and both Jennings and Carney have proven track records for thumbing their noses at both the Second Amendment and our own Article I Section 20 which says, in no uncertain terms, "A person has the right to keep and bear arms for defense of self, family home and state, and for hunting and recreation."

Power corrupts and absolute power corrupts absolutely. Both Delaware and New Mexico are deep "blue" states, both controlled by a rabidly anti-gun power structure.

Make no mistake, my friends. What happened in New Mexico, can happen right here in Delaware. It could happen in Wilmington, Dover, Newark, Seaford or maybe even on a state-wide basis. The stage has been set. Be prepared.

Those brave citizens who gathered on Sunday morning in Old Town Albuquerque to declare "We will not comply" in response to Governor Grisham's despotic power grab are to be commended and praised.

Let us hope and pray that our own Governor has more brains than his despotic Democrat colleague in New Mexico. But let there be no mistake, it could happen here.
